Guidelines:

- 1) Every nomination to any post shall be made in writing in the prescribed form and duly filled in all respect.
- 2) Prescribed nomination forms may be obtained from undersigned 'or' from Member of Election Committee in person 'or' through e-mail "or" from GEBEA Website and same duly filled up may be sent to the undersigned either by RPAD or in person as per the schedule of Election.
- 3) Nomination may be sent by post or handed over to the committee so as to reach before the last date and time as mentioned above. However soft copy of the nomination form may be sent through email to Chief Election Officer. Please note that nomination in Hard Copy within time frame only will be entertained.
- 4) Nomination form to be submitted along with Rs. 500/- non refundable fee. Nomination fee to be paid by DD/Cheque/On line in favor of GEB Engineers Association, Payable at Vadodara. The Bank account detail of GEB Engineers Association is as under.

Nomination without fee will not be entertained.

- 5) A member cannot propose or second more than one individual for anyone post or the same individual for more than one post.
- 6) A candidate may withdraw from the contest any time before the last date and time mentioned above. However Chief Election officer will decide the issue of withdrawal of nomination form after due time in large interest of saving procedural time of the election.
- 7) The members of the Association shall produce their ID Card having photograph issued by election committee or any other valid ID proof having photograph.
- 8) In case of dispute regarding payment of fees, copy of pay slip in which fees deducted shall be considered. However, in any dispute regarding payment of fees for membership of association, the decision of the Secretary Finance shall be final.
- 9) Proxy Vote or Postal Vote or Voting by Sealed Cover will not be allowed
- 10) The list of Voters will be placed on GEBEA website for verification. If any correction on account of Transfer/Promotion/Resignation of Member is their same is to be intimated to Chief Election Officer on or before 10th December, 2022 through respective Circle Secretary & General Secretary. Please note



that the list of Voters will be fridge w.e.f. 11th December, 2022 and no addition/alteration will be allowed thereafter.

- 11) In case of any complaint/representation regarding Voter list after the 11th December, 2022 regarding eligibility of voter find incorrect in such circumstances respective voter will be debarred and not allowed to vote.

Note:

For any dispute, the rules and guidelines given under constitution of GEBEA shall be final and regarding interpretation of rules and on points where rules are not clear, decision of the election Committee shall be final.
